Sub: *Circular No.11 - Completion of the Village ^{Town} Directory for the District Census Handbook (DCHB), Census of India 2011*

Sir,

I have the honour to inform you that District Census Handbook (DCHB) is a unique publication brought out un-interruptedly by the Census organization since 1951 Census. DCHB contains several demographic and socio-economic characteristics village-wise and town wise of the district alongwith the status of availability of civic amenities, infrastructure facilities etc. It also contains data at the grassroot level for the administrative and planning purpose at micro level as well as academic studies. The scope of the DCHBs was enhanced in each census by adding new items for collection of data at village and town level so as to measure the development which have taken place in the intervening period as well as to identify the possible gaps which will need to be filling through plan schemes by the authorities concerned. The new items were added, keeping in view the pace of economic development in the country. To continue this series in 2011 Census as well, District Census Handbook (DCHB) is to be brought as usual. It will consist of two Parts viz Part-A: Village & Town Directory and Part-B: Primary Census Abstract. The data is to be collected as on 31st December 2009. Data on Rupa which is the only census town will be included in the Town Directory. The presentation of data in the Village Directory will be crush wise as in 2001 census.

To ensure the consistency and reliability of the data collected now for the Village and Town Directory, these are to be scrutinized with reference to the 2001 Census data so that there are no glaring discrepancies or inconsistencies between them. For this purpose, 2001 DCHB of the respective District will also be sent to the concerned Census Staff so that they can check the data and compare it with that being furnished now. However, care should be taken in respect of villages which have undergone a jurisdictional change.

In this regard, the format of village/Town Directory as per the number of villages/towns, Instruction Manuals, Village list are being sent to the Districts. The village Panchayat Head/Circle Officer will put their signature on each filled in VD/D as the case may be.

The Charge Officers may kindly provide the relevant information regarding the concerned villages and towns of their respective Charges in collaboration with the census staff deployed in the Districts.
