Census Circular- 2

Sub : *Census of India 2011- Fixing of boundaries of Administrative Units during the period of census operations*

Sir,

I have the honour to say that, the Pre-Test of census of India , 2011 has already been conducted and now we are towards first phase of main census ie Housing and House listing census to be conducted ail over the country from April'2010 followed by the Population Enumeration in February - March' 2011.

To ensure complete coverage of the census, the entire country will be divided into small Enumeration Blocks with in the frame work of the administrative unit in the state. The process of demarcating Enumeration Blocks will be taken up in advance of the House listing Operations and they will be marked on the census maps to obviate overlapping or omission of areas.

For the efficient conduct of the census operations, it is necessary to ensure that the boundaries of administrative units are not to be disturbed after the blocks have been demarcated and until the census operations is completed. Hence, whenever any change in the jurisdiction of the present administrative units are proposed to be effected, it would be desirable to effect the changes well before the Enumeration Block are demarcated ie before 31st Dec'2009.

In the circumstances, proposal for making any changes in the boundaries of the existing Villages , Circles, Police Station, Development Blocks, Subdivision, District etc. or for forming new units which may be pending or which may be taken up in near future, may kindly be finalized and given effect within 31st Dec,2009. All changes may kindly be intimated to this office and I also have the honour to request you kindly that no change whatsoever is made in the boundaries of these administrative units during the period of 1st January'2010 to 31st March'2011.

In this regard, I am to inform you that this office has already received many new villages from different district of Arunachal Pradesh. But I would Like to mention here that no specific location of new villages were given. This information is very essential to locate village in the map as well as to give Permanent Location Code Number (PLCN) of the villages so as to avoid duplication or overlapping of any villages in the district. In the mean time, Officers/Officials from this Directorate will visit the different district to collect the actual location of the new villages, which has come up after 2001 census. So, I have the honour to request you kindly to issue suitable instruction to all the Dy. Commissioners/Circle Officers of the State to cooperate with our Officers/Officials in this matter.
