Sub:- **Monthly progress report in connection with Census -2011.**

Sir,

1. Training for the Master trainers has been organized at the District HQs. Important guidelines have been given to the Master trainers so as to enable them to become well conversant about census manual.
2. Training for the enumerators and supervisors has been completed successfully at all the circles of the District. Specific attention has been given for the field functionaries who attended the training programme from the interior parts of the district.
Seven numbers of Master trainers had been made available by DCO, Shillong for imparting training at 15 circles of the district. As a result of which enumerators and supervisors from Sagalee, Pareng, Leporiang and Toru circles had been clubbed together at ADC HQs Sagalee and field functionaries from Kimin, Kakoí, Gumto and Doimukh circles had been clubbed together at EAC HQs, Doimukh for training purpose only.
3. House listing and Housing census has started from 15th April 2010 in all the circles of the district taking proper care of all the guidelines of the census department.
4. Group meetings with all the charge officers and ZPM members was held at the District HQs, Yupia on 22/4/10 and 23/4/10 respectively and necessary guidelines have been given to them for keeping strict vigilance during the whole period of enumeration of their respective circles.
5. Field supervision work along with close contact with the field functionaries have been kept regularly so that census data collection work may continue smoothly.

Specific Problems:

1. Kit items for enumerators / supervisors had not been made available to some of the field functionaries of the district due to shortage of items. However, matter has been taken up with the DCO, Shillong.
2. Some of the training materials had not been supplied to a few numbers of circles during circle level training programme, however training was completed successfully.
3. Sufficient quantity of census schedules have not been made available to most of the circles of the district. DCO, Shillong has been asked to send more numbers of schedules immediately.
