Respected Sir,

I would like to bring to your kind attention the progress made in the Houselisting and House Census Operations of Rumgong Sub-division in the month of March 2010. The following preparatory steps have been taken to ensure smooth and timely conduct of the Operations:

1. The Charge Officers of the four Circles in Rumgong Sub-division – Rumgong, Kaying, Payum and Jomlo-Mobuk – attended the Census training conducted at the District Headquarters in Aalo on March 19, 2010. They are now proficient in the various aspects of census enumeration. I have been informed that master trainers will be appointed and sent to Rumgong by the Deputy Commissioner, West Siang District, Aalo for further training of the enumerators and supervisors.
2. As per instructions received from the District Statistical Officer, the respective Charge Officers within my sub-division have appointed enumerators and supervisors according to the number of enumeration blocks determined at the District level for each Circle. Formal appointment letters have been issued to all of them.
3. In accordance with the guidelines received from the Director, Census Operations, I have issued an order prohibiting leave for teachers engaged in the census activities till the completion of the enumeration process. I have also informed them that they will be eligible for compensatory leave later on.
4. I am in regular touch with the Charge Officers of my jurisdiction to ensure that they are performing their duties systematically and in a timely fashion.


