- 2. In exercise of the powers conferred by Sub-section (4) of Section 4 of the said Act, the Governor of Arunachal Pradesh, hereby further delegates to the officers named in para 1, SL. 1 to 7 above, the power of appointing Census Officers within local areas specified against their names.
 - 3. Under Section 6 to 7 of the said Act, the Governor of Arunachal Pradesh hereby appoints the Deputy Commissioners to be the officers on whose direction or order the officers and persons named in these sections shall perform the duties of Census Officers to give assistance as set forth therein.
 - Under Section of the said Act, Census Officers are hereby directed to ask all questions necessary for correcting filling in the prescribed census forms and schedules.
 - In exercise of the powers conferred by Section 12 of the said Act, the Governor of Arunachal Pradesh hereby authorises the Deputy Commissioners and Addl. Deputy Commissioners to accord previous sanction for the institution of prosecution under the Census Act.
 - 6. The Governor of Arunachal Pradesh hereby also authorises the Census Schedules as may be notified at the appropriate time for the 2011 Census.
